

Letter of Intent

This letter of intent on collaboration is concluded between:

- 1) Antidoping Schweiz, Talgutzentrum 17, Postfach 606, 3000 Bern 22, Schweiz,
and
- 2) Nationale Anti-Doping Agentur Deutschland (NADA), Heussallee 38, 53113 Bonn,
Deutschland,
and
- 3) Agence française de lutte contre le dopage afd, 229, boulevard Saint-Germain,
75007 Paris, France,
and
- 4) Nationale Anti-Doping Agentur Austria GmbH, 1030 Wien, Rennweg 46 – 50/Top 1,
Österreich

subsequently referred to as party or parties.

1. Subject of the collaboration

The collaboration covers the following areas:

Doping controls;

Doping prevention and providing information about doping;

Research;

Legal aspects of anti-doping.

This will be put into practice by close cooperation, the exchange of information and specialists and by study visits.

2. Scope of the collaboration

Organizational structure;

Sharing of documentation and experiences for the purpose of improving both parties' organizational structures.

Exchange of information and specialists:

Exchange of specialists;

Sharing experiences of IT systems for anti-doping administration (ADAMS or other systems);

Exchange of information and prevention materials, including joint further development; collaboration and sharing of information during research projects.

Doping controls:

Cooperating closely in the testing of own athletes in the partner country;

mutual recognition of TUEs and DOUs;

Exchange of information about tests conducted in each party's country on athletes from the partner country.

Study visits:

The aim is to hold two study visits a year, each in one of the partner countries. Appropriate specialists for the previously agreed agenda will participate in these visits.

3. Persons responsible

4. Duration

Collaboration lasts for one calendar year and is automatically renewed for a further calendar year unless terminated by either party with one month's written notice.

5. Costs

The parties hereby agree on the following principles:

Travel expenses, overnight accommodation, meals and other expenses will be borne by the parties themselves.

Costs for meeting rooms and other infrastructure will be borne by the host party.

The apportionment of other costs, such as expert reports or joint projects that are outside the scope of this collaboration, will be agreed in advance by both parties.

6. Disagreements

Any disagreements that may arise from this collaboration will be resolved amicably.






